
## City of Kodiak Kodiak Police Department Security Controls Upgrade PN 22-07/4068 Addendum No. 3 June 20, 2022

The following change(s) and/or clarification(s) are made to the Plan and Specification Documents of Request for Proposals (RFP) for the Kodiak Police Department Security Controls Upgrade PN 22-07/4068:

## 1. Answers to the following Questions:

- a) Addendum No. 2, Question / Answer #19 needs more clarification:
  - i. The question posed was "what is tag count of existing GUI software", the answer did not answer this question
    - Answer: Thank you for the clarification, the question was misunderstood.
  - ii. GUI software comes in tag counts, example, 50,200,800, 1500 etc. Can the GUI "tag counts" of each workstation be provided, this information was not in the ECS Security Electronics O&M documentation?
    - Answer: Tag counts do not appear to be available in documentation.
- b) Why where new project floor plans included in Addendum No.2?
  - i. What were changes to these documents? Typically with any addendum (whether floor plans and or div 28 specifications) there are "clouded" areas that changed from original doc's to addendum doc's
    - Answer: New plans in Addendum No. 2 were originally intended to be released with RFP. Instead, a preliminary review set was included which is why nothing was clouded. Changes of note are as follows. Verbiage and specs updated to require new cabling to all card readers. This was done to eliminate any issues with OSDP readers on existing cabling. 283200.D.5 was added to reinforce the need to update camera callups on the touchscreen, and the gooseneck cameras at the vehicle gate were shifted to alternate no. 2 on sheet E0.2.
- c) Would it be possible to provide screen shots (pictures) of all current locking control screens? This will aide in understanding current system control / monitoring field devices and a better path for GUI tag counts
  - Answer: Screen shots (3) are attached.
- d) Will the bid opening be streamed as a live event to where bidders can watch / listen in on openings?
