Incumbents are responsible for performing skilled and semi-skilled maintenance tasks on City streets and rights-of-ways, wastewater collection and storm water conveyance systems, landscapes, harbor facilities, and buildings that could include: performing inspections; implementing routine preventative maintenance and repairs; evaluating equipment and supplies as necessary to ensure effective operations; executing special projects/assignments such as snow removal; responding to emergency spill containment and cleanup calls and related events by evaluating hazards and determining corrective actions; and leading the work of seasonal and apprentice employees.

The Maintenance Technician is distinguished from the Maintenance Assistant in that independently performs a wide range of maintenance activities.

PHYSICAL REQUIREMENTS:
